Subject: The Merchant Shipping (Minimum Requirements of Medical Treatment on Board Ships) Order of 2010 (P.I 223/2010) –Definitions

I refer to the above subject and further to my Circular No.15/2010 dated 9/6/2010, I wish to further inform you of the following:

1.The categories of vessels (A,B,C) mentioned in Order P.I.223/2010 , are described in Schedule I of the Merchant Shipping (Minimum Requirements of Medical Treatment on Board Ships)Law of 2002 (Law 175(I)/2002).

More precisely they are the following:

CATEGORIES OF VESSELS

A. Sea-going or sea-fishing vessels, with no limitation on length of trips.

B. Sea-going or sea-fishing vessels making trips of less than 150 nautical miles from the nearest port with adequate medical equipment (1) .

C. Harbour vessels, boats and craft staying very close to shore or with no cabin accommodation other than a wheelhouse.

(1) Category B shall be extended to sea-going or sea-fishing vessels which make trips of less than 175 nautical miles from the nearest port with adequate medical equipment and which remain continuously within range of helicopter rescue services. To this end, each Member State shall forward up-to-date information on the areas in which routine helicopter rescue services are provided, and the circumstances in which they operate: (a) to the other Member States and the Commission; and (b) to the captains of vessels flying its flag or registered under its plenary jurisdiction who are, or are likely to be, concerned by application of the first subparagraph of this footnote; the information shall be forwarded in the most appropriate way, for example through radio-consultation centres, rescue coordination centres or coastal radio stations.

2. For the following medicines mentioned in the Merchant Shipping (Minimum Requirements of Medical Treatment on Board Ships) Order of 2010 (P.I 223/2010), the quantity specified, is considered sufficient regardless of crew size and it appears as follows :

3. In Schedules II and IV of the above mentioned Order, the recommended quantity of the medicines is for 10 seafarers. However in cases where the number of seafarers differs, the quantity should be adjusted using linear interpolation.

The present circular should be kept on board vessels flying the Cyprus flag.
