

## Circular 05/2009 (ISM)

### 1. General

Passengers on board passenger ships can expect and trust on a high safety standard and a sufficient information system which will facilitate search and rescue and the efficient organisation after an accident that might occur. Therefore, we would like refer the operators of passenger ships to SOLAS reg. III/27 and Directive 98/41/EC.

Before departing from a port it has to be verified that the number of persons on board of a passenger ship does not exceed the number of persons, which the ship and its safety equipment is permitted to carry.

The operators of passenger ships are requested to verify if their procedures are in line with the requirements or if the procedures need modification.

Especially the following facts should be involved in the internal review:

- How it is ensured that every person is counted and, if required, registered before leaving the port to provide these information in case of emergency immediately?
- Do procedures exist if the number of persons on board threatens to be exceeded or is exceeded?

## 3. General references

### Passenger registrar:

The responsible shore based person designated by a company as responsible for the keeping of information on persons who have embarked on a passenger ship.

### Registration system:

Registration systems shall meet the following functional criteria:

- Readability (The required data must be in a format that is easy to read.)
- Availability (The required data must be easily available to the designated authorities.)
- Facilitation (The system must not cause any undue delay for passengers embarking or disembarking the ship.)
- Security (The data must be appropriately protected against accidental or unlawful destruction or loss and unauthorized alteration, disclosure or access.)

Registration systems have to be regarded as part of the Safety Management System and have to be implemented accordingly.

Data keeping:

Personal data collected in accordance with the requirements shall not be kept longer than up to the end of the voyage.

Approval:

Registration systems will be approved and random checked by the Ship-Safety-Division. Auditors of the Ship-Safety-Division will carry out the approval and verification during safety management audits.
