- ④ If a flag state inspector is attended, he will carry out the audit and issue an ISSC.
- ⑤ Authorization is granted to NK-Kuala Lumpur Office. Therefore, upon receiving application, contact NK-Kuala Lumpur Office
- ⑥ Limited to the ship to which the society has issued SMC or to ships under the management of the company to which the society has issued DOC.
- ⑦ Audit for Passenger ship to be conducted by the Government.
- ⑧ Limited to selected ships, other than Passenger Ships, enrolled under Enhanced Authorization Scheme. OIC is to contact SMD when received an application.
