Japan Coast Guard (J.C.G) has informed that additional ship security information to be reported before arrival to Japanese Port accompanying the enforcement of partly amended Japanese national regulation for the Security of International Ships and Port Facilities, as follows.

From July 16th 2018, please note that it will target all ships for which come / intend to enter Japanese Ports directly from foreign ports.

For Japanese Flagged Ship......Records of Port of Call after December 9th 2016 For Non-Japanese Flagged Ship.....Records of Port of Call after February 19th 2016

# ClassNK Technical Information No TEG 1151 attion of Reporting Items on Security Information of Ship

Important notice to mariners who enter Japanese port from abroad

Based on the law of ship security and port facilities which came into force on 1 July 2004, all ships that depart from foreign port and intend to enter Japanese port are required to report their security information of ship to a designated Japan Coast Guard office 24 hours before their arrival.

Effective on 16 July 2018, some reporting items on the security information of ship will be changed.

## (Changes)

Following items are added to report

- · For Japanese Flagged Ship
  - → Records of Port of Call in North Korea after 9 December 2016
- · For Non-Japanese Flagged Ship
- → Records of Port of Call in North Korea after 19 February 2016

All ships who enter Japanese port from abroad are required to report these information regardless of their nationality, size, type and etc.,

All ships that enter special areas (e.g. Bay of Tokyo, Bay of Ise, Seto inland sea) are also required to report these information.

This report is only required for those ships come from a foreign port directly to Japan. Therefore, it is not necessary for ships that have already entered Japanese ports and keep domestic voyages.

## ♦ Where to report?

\* Please report to local JCG office in charge of the port where you intend to enter.

If you enter specific areas <u>without determining Japanese port of call</u> or <u>without calling on any Japanese ports</u>, please report to local JCG office designated by public notice.

(Please contact Regional JCG headquarters for more detail.)

## ♦ Who should report?

- \* Captain is responsible for this report. However, owners and ship agents authorized by the captain or ship owner can also submit the report.
- ♦ How to report?
- \* NACCS, fax, e-mail and hand delivery are accepted.

  NACCS is preferable because it ensures smooth and reliable communication.
- ♦ What should you do if you fail to report 24 hours before the arrival due to bad weather or some other inevitable circumstances?
- \* Please report immediately to a designated local JCG office.
- \* When you face imminent dangers and need to enter port urgently, please report them as soon as you enter the port. (Please contact Regional JCG headquarters for more detail.)

- ·For the purpose of counter terrorism, a ship arriving from abroad is requested to report her security information of ship before arrival.
- Once you make a report, you may enter Japanese port as usual. JCG officials may ask some questions or give you some instructions for your entry, please follow their instructions.
- A captain of the ship who did not make a report or those who made a false report may be fined up to 500,000 yen or sentenced to up to one year imprisonment. It may also cause a significant delay of your entry if you fail a proper report.
