DMA RO Circular no. 021

Regarding the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers, 1978, as amended

1. Introduction

Implementation of the STCW Convention may raise various questions during Port State Control inspections because of differences in the application of the Convention in different countries.

The intention of this publication is to explain the procedures followed by the Danish Maritime Authority.

The procedures comply with the provisions of the Convention, as amended. Furthermore, attention is directed to the IMO STCW.7 Circulars, which contain internationally agreed clarification regarding the application of the provisions of the STCW Convention, as amended.

2. **Explanatory note**

Supplementary remarks to several regulations, etc. are given in the following appendix 1.

With this circular, the Danish Maritime Authority hopes to contribute to a smooth completion of Port State Control inspections as far as they concern the application of the STCW Convention in Danish ships and the manning of ships.

As stated in Article X of the STCW Convention, all possible efforts shall be made by Port State officials to avoid a ship being unduly detained or delayed when exercising control. It is also stated that, if a ship is unduly detained or delayed, it shall be entitled to compensation for any loss or damage resulting therefrom.

Watchkeeping certificates for ratings	Watchkeeping certificates for deck ratings issued in accordance with regulation II/6 of the STCW Convention in force before 1 February 1997 (STCW 78) are valid for service after 1 January 2017 as equivalent to an II/4 certificate issued in accordance with the STCW-95 Convention, as amended.
	If an issued Danish Certificate of Proficiency as an able ship's assistant is endorsed in accordance with regulation II/4, no separate certificate is needed or issued.
Watchkeeping certificates for engine ratings	According to the STCW Code, A-VIII/2, engine watchkeeping for ratings is not required.
	In Danish vessels, engine ratings do not take part in an engine-room watch, thus watchkeeping engine ratings are not prescribed in minimum safe manning documents, and watchkeeping certificates for engine ratings issued in accordance with regulation III/4 of the STCW Convention are not required in Danish vessels nor issued.
Certificates of competency issued by the Government of the Faroe Islands	The Danish Maritime Authority accepts Certificates of Competency issued by the Government of the Faroe Islands, and such certificates are exchangeable with certificates issued by the Danish Maritime Authority. Therefore recognition of Certificates of Competency issued by the Government of the Faroe Islands is unnecessary.
Ships fitted with ECDIS	On ships fitted with ECDIS, watchkeeping officers must comply with the STCW Code, table A-II/1, about the competent use of ECDIS to maintain safety of navigation.
	Persons holding Certificates of Competency as a watchkeeping officer with the limitation "Not valid for ships fitted with ECDIS" must not serve as watchkeeping officers on ships fitted with ECDIS.
	If no limitation regarding ECDIS is stated on the Certificate of Competency as a deck officer, the holder fulfils the STCW Code, table A-II/1 – table A.
Medical stand- ards	Seafarers, including masters, serving on or about to start serving on Danish merchant vessels must hold a Danish Health Certificate, which contains the result of a Danish medical certificate.
	Seafarers need to bring on board only the Health Certificate, and not the medical certificate.

INTERNATIONAL CONVENTION ON STANDARDS OF TRAINING, CERTIFICATION AND WATCHKEEPING FOR SEAFARERS (STCW), 1978, AS AMENDED

Guidance for port State control officers on issues related to certificates of competency

- The Maritime Safety Committee, at its seventy-fifth session (15 to 24 May 2002), noted that, during inspections, some port State control officers were requiring documentary evidence of successful completion of short-course training meeting the requirements in regulations VI/1, VI/2, VI/3 and VI/4 from seafarers holding certificates of competency issued under regulations II/1, II/2, II/3, III/1, III/2, III/3, and VII/2 of the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers (STCW) 1978, as amended, even though the Convention includes this training as a pre-requisite for the issue of these certificates of competency.
- The Committee agreed that certificates of competency issued in compliance with regulations II/1, II/2, II/3, III/1, III/2, III/3 and VII/2 of the STCW Convention 1978, as amended, also included the following competency requirements of chapter VI of the STCW Convention: proficiency in survival craft and rescue boats other than fast rescue boats (regulation VI/2, paragraph 1), training in advanced fire fighting (regulation VI/3), and medical first aid (regulation VI/4, paragraph 1).
- 3 The Committee further agreed that it was therefore not necessary for the holders of certificates of competency to carry additional documentary evidence in respect of those competences of chapter VI listed in paragraph 2 above.
- 4 Member Governments are invited to bring this information to the attention of all concerned, especially port State control officers.
