**Subject: The Merchant Shipping (Medical Examination of Seafarers and Issue of Certificates) (List of Approved Doctors) Notification of 2017 (P.I. 77/2017)**

1. I refer to the above subject and further to my Circular No.11/2015, regarding the issue of Notification P.I. 177/2015, I wish to inform you that the Minister of Transport, Communications and Works of the Republic of Cyprus, in exercising his powers under Section 12 of *the Merchant Shipping (Medical Examination of Seafarers and Issue of Certificates) Laws of 2000 and 2014, (Law 107(I)/2000 and 71(I)/2014)*, issued *The Merchant Shipping (Medical Examination of Seafarers and Issue of Certificates) (List of Approved Doctors) Notification of 2017, P.I. 77/2017* (published in the Official Gazette of the Republic No. 5002, Supplement III(I), dated 10.3.2017).
2. Seafarer's Medical Examinations in Cyprus should be carried out either by doctors in the private sector whose names appear in the following list of Approved Doctors or in Government General Hospitals (Nicosia, Limassol, Larnaca, Ammochostos, Paphos).
