APPLICATION FOR AN EXEMPTION/DISPENSATION FROM AN INTERNATIONAL CONVENTION, REQUIREMENT OR EXTENSION OF A STATUTORY SURVEY PERIOD UNDER AN INTERNATIONAL CONVENTION

TO: **SHIPOWNERS, SHIPS' OPERATORS AND
MANAGERS, MASTERS, FLAG STATE SURVEYORS**

APPLICABLE TO: ALL SHIPS
EFFECTIVE AS FROM: Date of this Circular

Monaco, 31st August 2010

When applying for:

- An Exemption/Dispensation from an International Convention requirement;
- An Extension of a statutory survey period under an International Convention; or
- The postponement of a survey, servicing period or any other applicable international requirement.

The following procedure should be followed:

- Application Forms should be addressed to the Classification Society or any other issuing body which issued the relevant Certificate.
- The issuing body will review the Application and communicate its comments to this Administration;
- The Exemption/Dispensation or the Extension will be granted **through** the Classification Society or the issuing body, which will issue the necessary documentation;
- **A Copy of the documentation issued by the Classification Society or the issuing body should immediately be forwarded to this Administration.**

The information supplied with the application should be inclusive of, but not limited to, the following:

- Reason and justification for the Application.
- Time period requested.
- Safety measures or equivalent arrangements which have been or will be introduced.
- Details of ship's schedule should a verification survey be requested.
