Object of Amendment

Rules for Approval of Manufacturers and Service Suppliers

Reason for Amendment

IMO Resolution MEPC.325(75) (published in November 2020) specifies that ballast water sampling and analysis are required to be carried out during the commissioning testing of ballast water treatment equipment from 1 June 2022. In relation to said requirement, the IMO published circular BWM.2/Circ.70/Rev.1, "2020 Guidance for the Commissioning Testing of Ballast Water Management Systems", in December 2020. The Society has already incorporated references to said circular into its Rules for Approval of Manufacturers and Service Suppliers.

IACS, in turn, subsequently published Recommendation (Rec.) No. 180, its own recommendation for conducting said commissioning testing in accordance with BWM.2/Circ.70/Rev.1, in April 2024 and then added references to it to IACS Unified Requirement (UR) Z17 in October 2024.

Accordingly, relevant requirements are amended to add references to Rec. No. 180.

Outline of Amendment

Adds references to Rec. No. 180 to the Rules for Approval of Manufacturers and Service Suppliers.

Effective Date and Application

Effective date of this amendment is 1 January 2026.
