Tonnage Certificate.

To shipowners concerned,

International Convention on Tonnage Measurement of Ships, 1969 (hereinafter referred to as "the Convention") is being applied to :

- (1) new ships of which keel was laid on July 18, 1982 or after; and
- (2) existing ships for which shipowner requests issue of an International Tonnage Certificate(1969)(hereinafter referred to as "the Certificate").

The Convention, however, shall apply to all existing ships on July 18, 1994 or after.

Therefore all existing ships which do not have the Certificate are subject to the Convention and are to have the Certificate by that day. At present 2,500 ships of the Society's classification do not have the Certificate. We are very much afraid that the application for the Certificate will be made by most shipowners just before the date in the light of our experience, because in such case we would not be able to process all of those applications by the date and it would cause the shipowners great inconvenience.

To avoid such inconvenience and to issue the Certificate to all existing ships by the effectuation date of the Convention, the following procedure is proposed by the Society besides usual application for the Certificate.

The Society would appreciate it very much if you would apply for issue of the Certificates as early as possible, noting the above-mentioned situation.

Procedure

1. Application for tonnage calculation

- (a) An applicant applies for tonnage calculation in accordance with the Convention by the attached application form. (See Attachment (1).)
- (b) Time limit of the application is July 17, 1993 (One year before the effectuation of the Convention)

If the application is not made by the date, the Society will not be able to guarantee that the Certificate will be issued by July 18, 1994.



- (c) The Society informs the applicant of the results of the tonnage calculation (Gross tonnage and Net tonnage) by the attached form. (See attachment (2)1/2.) (For some ships, gross tonnage and/or net tonnage becomes smaller than those current.)
- (d) Fees and expenses for the tonnage calculation will be charge at the time when the Certificate is issued. (See 2 (c) and (d))

2. Issuance of the Certificate

- (a) After receiving the results of tonnage calculation, the applicant informs the Society of the date desired for the issue (July 18, 1994 or before) of the Certificate by the attached form. (See Attachment (2)2/2.)
- (b) The Society issues the Certificate based on the results of tonnage calculation stated in (1).

(Note)

In case where the date of issuance of the Certificate is before July 18, 1994, the proviso of (2)(d) of Article 3 of the Convention is not applied. (See attached reference document.)

- (d) Fee for issuance of the Certificate and for tonnage calculation will be charged to the applicant who requests issue of the Certificate.
- (e) In case where there is no need the Certificate be issued due to selling or scrapping of the ship, change of her service area to non-international, her registry to another society, etc., charge will not be made to the applicants.

Excerpt of International Convention on
Tonnage Measurement of Ships, 1969

1969年の船舶のトン数測定に関する国際条約抜粋

ARTICLE 2

Definitions

For the purpose of the present Convention, unless expressly provided otherwise:

- (1) "Regulations" means the Regulations annexed to the present Convention;
- (2) "Administration" means the Government of the State whose flag the ship is flying;
- (3) "international voyage" means a sea voyage from a country to which the present Convention applies to a port outside such country, or conversely. For this purpose, every territory for the international relations of which a Contracting Government is responsible or for which the United Nations are the administering authority is regarded as a separate country;
- (4) "gross tonnage" means the measure of the overall size of a ship determined in accordance with the provisions of the present Convention;
- (5) "net tonnage" means the measure of the useful capacity of a ship determined in accordance with the provisions of the present Convention;
- (6) "new ship" means a ship the keel of which is laid, or which is at a similar stage of construction, on or after the date of coming into force of the present Convention;
- (7) "existing ship" means a ship which is not a new ship;

第2条

定義

この条約の適用上、別段の明文の規定がない限り、

- (1) 「規則」とは、この条約に附属する規則をいう。
- (2) 「主管庁」とは、船舶の旗国の政府をいう。
- (3) 「国際航海」とは、この条約が適用される国から国外の港に至る航海又はその逆の航海をいう。この場合において、締約政府が国際関係について責任を有する地域及び国際連合が施政権者である地域は、別個の国とみなす。
- (4) 「総トン数」とは、この条約に従って算定される船舶の全体の大きさをいう。
- (5) 「純トン数」とは、この条約に従って算定される船舶の有用容積の大きさをいう。
- (6) 「新船」とは、この条約の効力発生の日以後にキールが据え付けられる船舶又はこれと同様の建造段階にある船舶をいう。
- (7) 「現存船」とは、新船でない船舶をいう。

(8) "length" means 96 per cent of the total length on a waterline at 85 per cent of the least moulded depth measured from the top of the keel, or the length from the fore side of the stem to the axis of the rudder stock on that waterline, if that be greater. In ships designed with a rake of keel the waterline on which this length is measured shall be parallel to the designed waterline;

(9) "Organization" means the Inter-Governmental Maritime Consultative Organization.

ARTICLE 3

Application

(1) The present Convention shall apply to the following ships engaged on international voyages:

- (a) ships registered in countries the Governments of which are Contracting Governments;
- (b) ships registered in territories to which the present Convention is extended under Article 20; and
- (c) unregistered ships flying the flag of a State, the Government of which is a Contracting Government.

(2) The present Convention shall apply to:

- (a) new ships;
- (b) existing ships which undergo alterations or modifications which the Administration deems to be a substantial variation in their existing gross tonnage;

(8) 「長さ」とは、キールの上から測った最小型深さの85パーセントの位置における喫水線の全長の96パーセントの長さ又はその喫水線における船首材の前面からラダー・ストックの中心線までの長さのうちいずれか大きいものをいう。傾斜したキールを有するように設計された船舶にあつては、長さを測るための喫水線は、計画喫水線に平行なものとする。

(9) 「機関」とは、政府間海事協議機関をいう。

第3条

適用

(1) この条約は、国際航海に従事する次の船舶に適用する。

- (a) その政府が締約政府である国において登録されている船舶

(b) 第20条の規定によりこの条約が適用される地域において登録されている船舶

(c) その政府が締約政府である国を旗国とする船舶であつて登録されていないもの

(2) この条約は、次の船舶に適用する。

- (a) 新船
- (b) 現存船であつて現行の総トン数に実質的な変動をもたすこととなすと主官庁が認める変更又は改造の行われたもの

- (c) existing ships if the owner so requests; and
- (d) all existing ships, twelve years after the date on which the Convention comes into force, except that such ships, apart from those mentioned in (b) and (c) of this paragraph, shall retain their then existing tonnages for the purpose of the application to them of relevant requirements under other existing International Conventions.

(3) Existing ships to which the present Convention has been applied in accordance with sub-paragraph (2)(c) of this Article shall not subsequently have their tonnages determined in accordance with the requirements which the Administration applied to ships on international voyages prior to the coming into force of the present Convention.

- (c) 現存船であつて船舶所有者の要請があつたもの
- (d) この条約の効力発生の日の後12年を経過した時におけるすべての現存船。
もつとも、これらの現存船は、(b)及び(c)に規定するものを除くほか、
現行の他の国際条約の關係規定の適用上、現行のトン数を引き続き維持する。
- (3) 現存船であつて(2)(c)の規定に従つてこの条約が適用されたものについては、
その後は、国際航海に従事する船舶について主管庁がこの条約の効力発生前に
適用していた要件に従つてトン数を算定されることはない。
